STUDENTS RULES AND REGULATIONS:

The school is committed to promoting discipline, good health, conducive atmosphere for teaching and learning for its staff and the students at large.

With respect to BASEC's discipline policy, the consequences and remedies listed below may be used at the discretion of the teaching staff, disciplinary committee and the school administration to deal with any inappropriate student behaviour.

These basic rules and regulations are based on the G.E.S unified code of conduct tabulated below and it is our hope that these strategies will aid the students to become more consciously aware of their actions and developing social acceptable behaviours since discipline is our hallmark.

1. Cheating in Internal Examinations

Offence - Canning / Suspension and repetition

2. Cheating in External Examinations

Cancellation of results or face 2-3 years ban from writing external examination

3. Using Mobile Phone or Electronic Communication device during Examination

Cancellation of results or face 2-3 years ban from writing external examination

4. Involvement of Examination Leakage or Impersonation

Is an offence punishable by law

5. Bushy, Beard, Permed and Plaited hair

Is strictly prohibited and the offender will be dismissed

6. Drunkenness / Wee Possession/ Smoking and Drug Abuse

Is strictly prohibited and the offender will be dismissed

7. Incitement to riot or rioting

Dismissal for those pressured into rioting and parents should pay cost of damages

8. Breaking bounds / truancy, including refusal to attend classes

Manual work with counseling and One month suspension or withdrawal

9. Leaving school under false pretences

Manual work with counseling and One month suspension or withdrawal

10. Fighting / Bullying / Assault on students

Manual work with counseling and Dismissal on assault case

11. Sexual Misconduct / Case of Rape

Dismissal and the case maybe referred to the police for the law to take its course.

12. Flouting the school authorities and Assault on member of staff

One month suspension and Dismissal on assault case

13. Deliberate distortion of facts/ character assassination

Three months suspension and dismissal

One month suspension and repetition 15. Stealing / Gambling Suspension or dismissal based on the gravity of the offence 16. Any act to tarnish the image of the school To be considered on its own merit 17. Tattooing Indefinite suspension and the student is to resume school after erasure of the tattoo mark 18. Possession of mobile phone Seizure, smash it and three months suspension 19. Possession of offensive weapon Dismissal 20. Damage School Property Offenders pay three times cost of item damaged 21. Defacing school walls etc Offenders pay cost of painting with one month suspension 22. Occultism (Consulting mediums, soothsayers, casting spells in the school) Three months suspension or dismissal 23.
